Emily is a second-grader who was struggling with schoolwork and getting into conflicts with her classmates that often ended with her being suspended. Aware of her mother's struggles with addiction and homelessness, Emily's emotions ranged from sadness to anger; she felt her mother abandoned her. A United Way-funded after-school program became her lifeline. Trauma-informed staff devised a plan, helping Emily open up gradually. She was able to catch up on all her assignments and began participating in leadership projects and community service. Since starting the program, Emily has not had a single in or out of school suspension. Emily's grandmother credited the program with enhancing her self-esteem and confidence.

Our Programs & Initiatives

HEALTH • CRISIS INTERVENTION • FINANCIAL STABILITY

PRESCRIPTION DISCOUNT CARDS

No one should have to choose between food and medicine. But they do. Every day, people in our community cut their pills in half, skip doses or can't fill prescriptions because of the high cost. United Way recognizes how vitally important good health is in our community. Improving and promoting the health of individuals is one of our focus areas. We are pleased to be working with our local community partners to introduce and promote the SingleCare prescription drug discount program. These discount cards are offered **FREE** of charge and no enrollment is needed.

NUTRITION OUTREACH AND EDUCATION PROGRAM (NOEP)

Many working families face challenges in providing food for their households. Our dedicated NOEP coordinators collaborate with community members to ease the burden of food insecurity, frequently by aiding families in enrolling for SNAP (Supplemental Nutrition Assistance Program) benefits. Individuals may qualify if they receive unemployment benefits, rent relief, child tax credits, P-EBT or other COVID-19 relief funds.

CRISIS SUPPORT SERVICES

Crises hit everyone. Every day, United Way receives calls from our community members who need help accessing food, preventing eviction, securing transportation to work, filling prescriptions and other basic needs. United Way's Crisis Response can continue to prevent one small crisis from becoming a financial catastrophe by working closely with community partners to respond to emergency needs.

TRANSPORTATION ACCESS PROGRAM

Our area is seeing a growing transportation gap. United Way's Transportation Access Program offers free Lyft rides to residents without access to a vehicle or public transportation. These rides can be used for non-emergency medical appointments, job interviews, workforce development training, court appearances and other health and human services related appointments.


HUDSON VALLEY CA\$H

Hudson Valley CA\$H is a coalition of community partners representing libraries, human service agencies, local government, businesses, faith-based organizations and volunteers. Together with the IRS and AARP Foundation Tax-Aide, we are dedicated to promoting financial stability for individuals in Putnam, Orange and Dutchess Counties. The primary mission of the CA\$H Coalition is to provide free, reliable tax preparation assistance to low-to-moderate income residents so they can receive all the credits they are entitled to and keep every penny of their tax refund. Many depend on their refund to keep up with their rent, make a necessary car repair or pay down their credit card. For many of our neighbors, their tax refund might be the biggest check they receive all year.

Get to know your community.

Almost 100,000 households in our community need help.

We all know people who are ALICE: Asset Limited, Income Constrained, Employed — earning more than the Federal Poverty Level, but not enough to afford the basics where they live. ALICE workers were celebrated as essential heroes during the COVID-19 pandemic, yet they do not earn enough to support their own families.


